Action Plan for an innovative and competitive Security Industry

Objectives:

- Overcoming the fragmentation of the EU security market
- Reducing the gap from research to market
- Better integration of the societal dimension

The Action Plan (excerpt)

Overcoming market fragmentation

- ESOs to establish standardisation roadmaps in the areas of **CBRNE, border security, crisis management/civil protection**
- EC to propose legislation on EU-wide harmonised certification systems for **airport screening equipment** and **alarm systems**
- EC to issue standardisation mandates to ESOs for 'hybrid standards' (applicable to civil security & defence, e.g. on **Software Defined Radio - SDR**)

The Action Plan (excerpt, cont' d)

Better integration of the societal dimension

- Societal impact “checking” during the R&D phase
- EC to issue a standardisation mandate to the ESOs for developing a **“privacy by design”** standard

Action on Standardisation

CBRNE, border security, crisis management / CP

- Programming Mandate M/487, coordinated by CEN/TC 391
 - **JWG M/487, secretariat NEN (Ms Ying Ying Lau, email yingying.lau@nen.nl)**
 - **Contact CEN: Ms Alina Iatan, email aiatan@cencenelec.eu**
- Duration of action 6 months (January – June 2013)
- Three stakeholder workshops in months 3 - 4
- Call for Expression of Interest for experts (deadline 28 Dec' 12)

Action on Standardisation (II)

'Hybrid standards' for security & defence

- Standardisation Mandate M/512 for **Reconfigurable Radio Systems (RRS)** issued on 19 November 2012
- ETSI Work Programme within 12 months, total action 42 months

Standardisation Mandate for 'privacy by design'

- until March/April 2013 initial fact finding of COM
- April/May 2013 stakeholder workshop
- approx. November 2013 issuing of Mandate to ESOs

Action on Certification

Airport Screening Equipment

- Regulation to achieve mutual recognition of certification schemes
- approx. January – March 2013 stakeholder consultation
- approx. December 2013 adoption of proposal by COM

Alarm Systems

- approx. March – May 2013 stakeholder consultation
- approx. June 2014 adoption of proposal by COM
